2. The Management shall follow the Academic Regulations and examination schedule of JNT University Hyderabad.
3. The appointment of the Principal shall be ratified by the University.
4. The appointment of 50% of faculty members shall be ratified by the University.
5. During the period of Permanent Affiliation, the college needs to submit annual report alongwith Application, Inspection and Affiliation Fees and dues, if any, shall be paid immediately.
6. The University can withdraw the Permanent Affiliation at any time if the college does not satisfy the standards and norms of the University for Affiliation.
